Despite the recent up-tick in the local population, the only evidence there is any reciprocal increase in Crimes of Opportunity is in the category of Burglary of Vehicle.

Just over the past few weeks, several Burglary of Vehicle incidents have been reported in the Denmons community. None have been reported for Woodlake - but, that's not a pat-on- back or a slight on Denmon's residents. It means we've taken positive steps to prevent or deter criminal activity.

The raw data indicates there was an increase of

approximately 10 Burglary of Vehicle occurrences from 1/7/18 - 1/7/19 = 47, and from 1/7/19 - 1/7/20 = 57, and can be explained by the estimated increase in the local population by approximately 1200 new residents since 2018. So, how are the slight decreases in the incidence of other Crimes of Opportunity accounted for?

Not are just the local population densities changing, but so are the demographics.

The latest census, 1 July 2019, estimated Bell County's population at: 362,924. This is an increase of 17% from previous 2010 estimates (1.8% annual rate of change). This equates to an updated estimated population of approximately 362,270 for 2018.

The 5-mile-radius of the Woodlake area-of-interest (less the portion of the surface area of Lake Belton) encompasses approximately 45 square miles. This equals approximately 4% of the total 1,051 square miles for Bell County equating to a local area population for 2018 of 14,490 (P¹) and 14,517 (P²) for 2019.
